Los Angeles County Sheriff's Department (Acting Captain Vienna)

- No Part 1 crimes reported
- 4 aggravated assaults
- 11 larceny-theft incidents, including 1 vehicle burglary
- Traffic citations: April – 86, May – 104, June – 106
- Upcoming Event: National Night Out on August 5 from 5:00–9:00 PM at the Sheriff's Station; detectives and school resource deputies will be in attendance
- Technology Update: County Flock camera study completed; implementation is underway in unincorporated areas

Los Angeles County Fire Department (PIO Maria)

- 67 total responses in June
- 44 medical calls, with 28 patient transports
- 2 service calls
- 21 good intent calls
- No fires reported
- Safety Reminder: Stay hydrated and take precautions against heat-related illnesses
